Interests

My research focuses on decision making by various capital market participants involved in reporting and using financial statement information – including managers, board members, regulators, and investors. I explore decision making through two primary lenses: (1) monitoring and (2) disclosure effectiveness. My research on monitoring examines the determinants of decision-making by directors and regulators, while my work on disclosure effectiveness examines the role of various disclosure characteristics (e.g., textual readability, reporting frequency, etc.) on investors' trading decisions and price formation.
